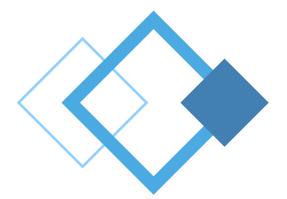

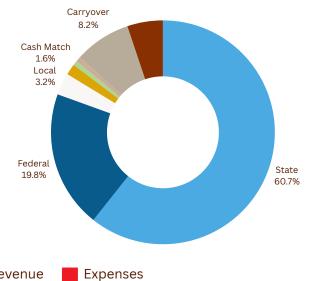
# MONTHLY REVIEW

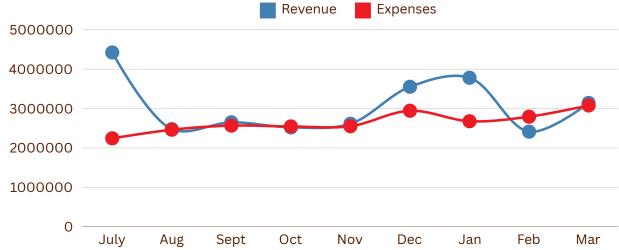
#### March 2024

Revenues and expenses will exceed our FY24 budget amounts. When comparing our figures to this time last year, March sees a 17% increase in revenues and a 31% increase in expenses.

Through 03/31/24 NKADD has a revenue of \$27,578,158.70 Which is 107% of our expected revenue.

- State Funds 60.7%
- Federal Funds 19.8%
- Other Funds 16.3%
- Local Funds 3.2%

(An 12% increase of \$49,304 from last March)

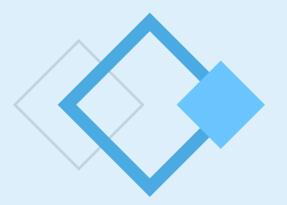
