




December 2024

Revenues and expenses are pacing ahead of our FY25 budget amounts. When comparing our figures to this time last year, December sees a 31% increase in revenues and a 30% increase in expenses.

Through 12/31/24 NKADD has a revenue of \$23,828,553 Which is 74% of our expected revenue.

(A 153% increase from last December)




