




November 2024

Revenues and expenses are pacing ahead of our FY25 budget amounts. When comparing our figures to this time last year, November sees a 32% increase in revenues and a 27% increase in expenses.

Through 11/30/24 NKADD has a revenue of \$19,861,751 Which is 62% of our expected revenue.

Cash Balance of \$5,588,813




Accounts Receivable Balance of \$2,257,772

(A 171% increase from last November)





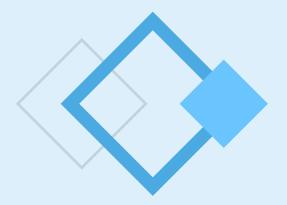
