### **District 6 Updates**

District 6 staff gave updates to the NKADD region. Carroll County 6-1084 US 42 Public Meeting was held. Working through environmental clearances. Working on the process of determining and obtaining approval for mitigation of park and cultural historic impacts. Carroll County 6-10037 KY 36 bridge project was awarded to Hayden Bridge Co. scheduled for construction spring 2025. Expected completion 12/2/25. Gallatin County 6-8910 I 71 Right of way funds authorized. Title work and appraisals started. Construction scheduled for December 2026. Grant County 6-20016 US 25 Environmental document approved. Consultant under contract to complete design from Crittenden Mt Zion Rd to County Park entrance. Pendleton County 6-80258 Ky177. Study of Ky 177 is complete. Study can be found on District 6 website.

### **Finalization and approval of the Boost scores for SHIFT**

NKADD staff presented the committee with the sponsorship projects with scoring and a first draft of boost points. The committee took advantage of boosting both ADD projects and District 6 projects to maximize scoring on 7 Projects. Through discussions Owen County proposed giving boost points to project IP2008364 in place of IP2008365. Committee approved. Also, Grant

County proposed giving boost points to Project 6-80315 in place of 6-80216.20. Committee approved. The final scores with boost points were approved by Judge Dills and Mayor Adams.

NKADD staff distributed copies of the newly updated By-Laws. The committee will review and submit any questions or changes. These By-Laws will be approved at the next Transportation Meeting on October 14<sup>th</sup>.
